4. FIRST AID MEASURES

Consult the National Poisons Information Centre (0800 POISON (0800 764 766)) or a doctor in every case of suspected chemical poisoning. Description of first aid measures

Advice for firefighters

Fire Fighting Procedures: Keep people away. Isolate fire and deny unnecessary entry. 6. ACCIDENTAL RELEASE MEASURES

Water Spill: If feasible, copper may be precipitated/-ultra filtrated with caustics or other chemicals and resulting sludge disposed of in a chemical landfill. 7. HANDLING AND STORAGE

Precautions for safe handling: Keep out of reach of children. Keep away from heat and sources of ignition. Avoid contact with eyes, skin, and clothing. Avoid breathing dust or spray mist. Wash hands thoroughly after handling. When using do not eat, drink or smoke. Remove and wash contaminated clothing before re-use. See Section 8: EXPOSURE CONTROLS AND PERSONAL PROTECTION.

Conditions for safe storage: Store in a dry place, out of direct sunlight. Store in original container. Keep container tightly closed in a well ventilated place. Keep locked up. Do not store with feed, seeds or foodstuffs.
